Welcome to the website of our medical practice. The following data protection declaration applies to the use of our website and the services offered on it. This data protection declaration informs you about the collection of personal data during your visit to this website. By using this website, you agree to the processing of your personal data in accordance with this data protection declaration.

The collection and processing of your personal data takes place in compliance with the applicable data protection laws and requirements. Furthermore, the doctor's practice declines any liability for the use of this website.

In principle, our medical practice only offers its services in Switzerland and is only aimed at people living in Switzerland.

Collection of general data and information

Every time the website is accessed, a series of general data and information is collected. This general data and information is stored in the server's log files. What can be recorded are (1) the browser types and versions used, (2) the operating system used by the accessing system, (3) the website from which an accessing system accesses our website (so-called referrers), (4) the sub-websites which are accessible via an accessing system on our website is controlled, (5) the date and time of access to the website, (6) an Internet protocol address (IP address), (7) the Internet service provider of the accessing system and (8) other similar data and information that serves to protect against threats in the event of attacks on our IT infrastructure.

This data and information is required to (1) display the content of our website correctly, (2) optimize the content of our website, (3) ensure the long-term functionality of our IT infrastructure and the technology of our website and (4) to provide law enforcement authorities with the necessary information in the event of a cyber-attack.

Our medical practice can also evaluate this data and information statistically and with the aim of increasing the data protection and data security of its IT infrastructure. The data and information collected will only be processed for the purposes mentioned above and will then be deleted.

Links from other websites

This website may contain links to websites of other providers. Our medical practice has no influence on these websites, their content, offers or availability or the data protection declarations and regulations applicable there. It therefore declines any liability.

Cookies and other services

Our medical practice may use cookies on its website. Cookies contain a so-called cookie ID, a unique identifier of the cookie, which assigns websites and servers to a specific Internet browser. A specific Internet browser can be recognized and identified via this unique cookie ID.

Such information about the use of this website (including your IP address) can, for example in the case of Google Analytics, be transferred to servers abroad and stored there. By using our website, you agree to the transfer of this data.

Our medical practice may use additional services from third parties to integrate their content and services, such as videos or articles, into the website. Such integration always requires that these third parties can collect and process the IP address and other information of visitors to this website. By using our website, you agree to this.

Communication options

The website of our medical practice contains certain information that enables quick electronic contact and direct communication, which also includes a general email address. If you contact us

using the communication options offered on our website, your contact details and content will only be used to process and answer your request.

Please note: It cannot be guaranteed that your data will be transmitted confidentially. Therefore, no confidential data (medical concerns, etc.) should be transmitted when contacting us.

Your rights

Based on the data protection law, you have various rights such as the right to information. To assert your rights, please contact the doctor's office. We would be happy to provide you with further information in this regard.

Our medical practice may adjust this data protection declaration at any time without prior notice. The current version published on our website applies. If the data protection declaration is part of a contract with you, in the event of an update we will inform you of the change by email or in another appropriate manner.
